## Acknowledgment of Risk and Responsibility

I have attended a Summit at Snoqualmie "Shreducation" class. I understand the purpose of the class is to help me better understand and apply the basics of Terrain Park safety and etiquette and how MY own behavior greatly affects my own safety as well as that of others. The class was not intended to teach specific freestyle skills or maneuvers.

I understand the following points of "Smartstyle" and understand it is my responsibility to apply them every time I am riding or skiing in any of The Summit at Snoqualmie® terrain parks:

### Make a Plan

I will make a plan every time before using a feature. I understand my speed, approach, and take off will directly affect my maneuver and landing.

### Look Before you Leap

I understand that it is my responsibility as the rider or skier to inspect every feature prior to using and throughout the day. Only I make the decision to ski or ride a particular feature. I should refrain from riding any features I am not comfortable with or do not have the proper level of skiing/riding skills to successfully use.

### Easy Style It

It is my responsibility to always ride or ski in control and within my ability level. I control the degree of difficulty and it is my responsibility to be sure I have sufficient skill and experience before attempting a particular feature. I should start small and work my way up.

### Respect Gets Respect

I will wait my turn and call my start. I will clear landing areas quickly. I will respect all signs, ropelines, and closures.

I understand the ATML Model (Approach, Take-off, Maneuver, and Landing) and will apply the concepts taught in class related to this model whenever riding in the terrain park. I acknowledge that freestyle skiing/riding is a hazardous sport that includes the risk of serious injury or death and the decisions I make as the skier/rider are the most important factors affecting my own safety. I acknowledge it is my responsibility to control my body position both on the ground and in the air and my failure to do so could result in serious injury or death.

## Liability Release, Acknowledgement of Risks and Hazards and Agreement Not To Sue

**WARNING:** Use of *The Summit at Snoqualmie*® Freestyle Terrain facilities, equipment and premises, hereafter "facilities" is HAZARDOUS and exposes you to risk of serious injury or death. Falls and injuries are a common occurrence and Freestyle skills require that you, the skier/rider, maintain deliberate and conscious control of your speed and physical body position, both on the ground and in the air, while properly using your equipment in variable weather and other conditions. Participate in these activities only within your own ability. Your safety and that of others is directly affected by your judgment in the severe elements of mountain terrain. Freestyle Terrain may contain jumps, hits, ramps, banks, fun boxes, jibs, rails, half pipes, quarter pipes, snowcross, bump terrain and other man-made or natural terrain features. PRIOR to using Freestyle Terrain, you are responsible for familiarizing yourself with these facilities and obeying all instructions, warnings and signs. Risks that are present on the slopes outside the terrain park are also present within the terrain park, including, but not limited to variations in terrain, snow conditions, weather, equipment, and risks associated with other skiers/riders. Be alert to all risks, hazards and dangers at these facilities. **Inverted aerials are not recommended.**

In consideration of being permitted to use *The Summit at Snoqualmie*®, Boyne USA, Crystal Mt., facilities, I agree to RELEASE, INDEMNIFY, DEFEND AND HOLD HARMLESS Ski Lifts, Inc., Boyne USA, Crystal Mt., its parent, subsidiary and affiliated companies, their respective agents, officers, directors, owners, contractors, volunteers, employees, insurers, real and personal property owners, and the U.S. Forest Service (collectively, the "Releasees") from any and all claims I might bring as a result of physical injury, including death, or property damage sustained in connection with my use of *The Summit at Snoqualmie*® facilities INCLUDING CLAIMS BASED ON NEGLIGENCE. I am fully aware of and accept all risks, hazards and dangers associated with using the Releasees facilities and I am fully responsible for any and all damage or injury of any kind that may result from my use of the Releasees facilities. I also agree to INDEMNIFY AND DEFEND the Releasees for any and all claims, including subrogation and/or derivative claims, brought by any third party or insurer, for injury or damage I may cause.

I hereby grant permission to the Releasees to use my image(s), picture or other likeness(es), (collectively, "Image"), whether video, digital or print, for commercial purposes or otherwise, without restriction as to frequency, duration or medium.

This document is a legally binding contract and is governed by the laws of the State of Washington. It shall be interpreted to provide as broad and inclusive a release of liability as is legally permissible, but it is not intended to assert any claims or defenses that are prohibited by law. I agree that exclusive jurisdiction and venue for any legal action against the Releasees shall be in the courts of King County, Washington. If any part of this agreement is determined to be unenforceable, all other parts shall still be given full force and effect. This Liability Release and all its components shall survive and continue in force beyond the termination of the current season with respect to any liability, damage or injury occurring prior to such termination.

I agree the terms of this **RELEASE** will apply to my use of the Freestyle Terrain for this season and for future ski seasons where I may choose to renew my Park Pass on line. By using the Park Pass this season and any future ski seasons I acknowledge my Agreement to the terms of this **RELEASE**.

As parent or guardian of the child named on this form (the "Child"), I have authority to enter into this agreement on behalf of the Child. I agree to **Indemnify, Defend and Hold Harmless** the Releasees for any and all claims whatsoever brought by the Child and all claims whatsoever brought by any third party arising in connection with the Child. I acknowledge that I have read and understand this document and am executing it on behalf of the Child, and that the Child and I will be bound by all its terms.
